Specificity	Mouse anti Human Alkaline Phosphatase antibody, clone BGN/03/66KF41 recognizes the tissue-nonspecific isozyme of human alkaline phosphatase commonly found in liver and bone tissue which catalyzes the hydrolysis of phosphate monoesters and shows minimal reactivity with the placental or intestinal isozymes.
Storage	Store at +4°C or at -20°C if preferred. Storage in frost-free freezers is not recommended. This product should be stored undiluted. Avoid repeated freezing and thawing as this may denature the antibody. Should this product contain a precipitate we recommend microcentrifugation before use.
