Preservative Stabilisers	0.09% Sodium Azide (NaN ₃)
Immunogen	Rabbit platelets.
Specificity	Sheep anti Rabbit platelets antibody reacts with lapine platelets. Binding to platelets is strongly positive with thymocyte-absorbed anti platelet serum and negative with thymocyte-absorbed normal sheep serum.
Storage	Store at +4°C or at -20°C if preferred. Storage in frost-free freezers is not recommended. This product should be stored undiluted. Avoid repeated freezing and thawing as this may denature the antibody. Should this product contain a precipitate we recommend microcentrifugation before use.
Shelf Life	18 months from date of despatch.
