P. aeruginosa is a gram-negative, opportunistic pathogen found in soil and water. It is a major cause of hospital acquired infection, and can affect any part of the body including the urinary, respiratory and gastrointestinal tracts in addition to skin, soft tissue, bones and joints.

Storage Store at +4°C or at -20°C if preferred.

Storage in frost-free freezers is not recommended.

This product should be stored undiluted. Avoid repeated freezing and thawing as this may denature the antibody. Should this product contain a precipitate we recommend microcentrifugation before

use.
