Specificity	Rabbit anti CARD11 antibody recognizes caspase recruitment domain-containing protein 11 (CARD11), also known as CARMA1. CARD11 is part of both the membrane associated guanylate kinase (MAGUK) family and the caspase recruitment domain (CARD) family. CARD11 is involved in NF-KappaB activation through interaction with signaling protein BCL10.
Western Blotting	Rabbit anti CARD11 antibody detects a band of approximately 133 kDa in Raji cell lysate and mouse tissue lysate under reducing conditions
Storage	Store at -20°C Storage in frost-free freezers is not recommended. This product should be stored undiluted. Avoid repeated freezing and thawing as this may denature the antibody. Should this product contain a precipitate we recommend microcentrifugation before use.
