Specificity	Rabbit anti CDK6 antibody recognizes cyclin-dependent kinase 6 (CDK6) also known as cell division protein kinase 6 or serine/threonine-protein kinase PLSTIRE. CDK6 is a member of the serine/threonine protein kinase family and is involved in regulation of cell-cycle progression during G1 phase and transition from G1 to S phase.
Western Blotting	Rabbit anti CDK6 antibody detects a band of approximately 37 kDa in cell lysates under reducing conditions
Storage	Store at -20°C Storage in frost-free freezers is not recommended. This product should be stored undiluted. Avoid repeated freezing and thawing as this may denature the antibody. Should this product contain a precipitate we recommend microcentrifugation before use.
