Specificity	Rabbit anti GDF15 antibody recognizes GDF15, also known as growth/differentiation factor 15, macrophage inhibitory cytokine 1, MIC1, NRG1 or PTGFB. GDF15 belongs to the transforming growth factor (TGF) beta superfamily. The expression of GDF15 is upregulated in the invasion and metastasis of certain cancers.
Western Blotting	Rabbit anti GDF15 antibody detects a band of approximately 34 kDa in SW620 cell lysate under reducing conditions
Storage	Store at -20°C Storage in frost-free freezers is not recommended. This product should be stored undiluted. Avoid repeated freezing and thawing as this may denature the antibody. Should this product contain a precipitate we recommend microcentrifugation before use.
