Specificity	Rabbit anti NCF1 antibody recognizes neutrophil cytosol factor 1 also known as NOXO2, p47phox or SH3PXD1A. NCF1 is involved in the production of superoxide via activation of the transmembrane NADPH oxidase 2 complex.
Western Blotting	Rabbit anti NCF1 antibody detects a band of approximately 45 kDa in cell lysates and tissue lysates under reducing conditions
