Specificity	Rabbit anti PAK2 antibody recognizes PAK2 also known as p21 protein (Cdc42/Rac)-activated kinase 2. PAK2 is a member of the p21 activated kinases (PAK) which act downstream of Rho GTPases. PAKs are involved in regulation of the cytoskeleton and nuclear signaling.
Western Blotting	Rabbit anti PAK2 antibody detects a band of approximately 65 kDa in Jurkat cell lysate and mouse tissue lysates under reducing conditions
Storage	Store at -20°C Storage in frost-free freezers is not recommended. This product should be stored undiluted. Avoid repeated freezing and thawing as this may denature the antibody. Should this product contain a precipitate we recommend microcentrifugation before use.
