Specificity	Rabbit anti PAK4 antibody recognizes PAK4. PAK4 is a member of the p21 activated kinase family (PAK). Members of the PAK family are involved in cytoskeleton dynamics, NADPH oxidase signaling and apoptosis.
Western Blotting	Rabbit anti PAK4 antibody detects a band of approximately 70 kDa in cell lysates under reducing conditions. Rabbit anti PAK4 antibody appears to detect several isoforms of PAK4.
Storage	Store at -20°C Storage in frost-free freezers is not recommended. This product should be stored undiluted. Avoid repeated freezing and thawing as this may denature the antibody. Should this product contain a precipitate we recommend microcentrifugation before use.
