Specificity	Rabbit anti PLD2 antibody recognizes PLD2 also known as phospholipase D2. The phospholipase D family catalyze the hydrolysis of phosphatidylcholine to produce phosphatidic acid and choline. Phospholipases are activated by tyrosine kinase and G protein coupled receptors.
Western Blotting	Rabbit anti PLD2 antibody detects a band of approximately 110 kDa in cell lysates under reducing

conditions

Storage	Store at -20°C Storage in frost-free freezers is not recommended. This product should be stored undiluted. Avoid repeated freezing and thawing as this may denature the antibody. Should this product contain a precipitate we recommend microcentrifugation before use.
