PTPN2 belongs to the protein tyrosine phosphatase family and regulates many cellular processes including hematopoiesis, inflammatory response, cell division and glucose homeostasis.
Western Blotting	Rabbit anti PTPN2 antibody detects a band of approximately 49 kDa in cell lysates under reducing conditions
Storage	Store at -20°C Storage in frost-free freezers is not recommended. This product should be stored undiluted. Avoid repeated freezing and thawing as this may denature the antibody. Should this product contain a precipitate we recommend microcentrifugation before use.
