Specificity	Rabbit anti PTPN6 antibody recognizes tyrosine-protein phosphatase non-receptor type 6 (PTPN6) also known as hematopoietic cell protein tyrosine phosphatase. PTPN6 belongs to the protein tyrosine phosphatase family and interacts with surface receptors such as CD117 and epidermal growth factor receptor (EGFR) which have undergone tyrosine phosphorylation.
Western Blotting	Rabbit anti PTPN6 antibody detects a band of approximately 65 kDa in cell lysates and tissue lysates under reducing conditions
Storage	Store at -20°C Storage in frost-free freezers is not recommended. This product should be stored undiluted. Avoid repeated freezing and thawing as this may denature the antibody. Should this product contain a precipitate we recommend microcentrifugation before use.
