Specificity	Rabbit anti SMAD2 antibody recognizes SMAD2, also known as mothers against decapentaplegic homolog 2. SMAD2 is a transcription factor belonging to the dwarfin/SMAD family. It is activated by transforming growth factor (TGF-beta) and activin type 1 receptor kinases to modulate transcription.
Western Blotting	Rabbit anti SMAD2 antibody detects a band of approximately 52 kDa in cell lysates and tissue lysates under reducing conditions
Storage	Store at -20°C Storage in frost-free freezers is not recommended. This product should be stored undiluted. Avoid repeated freezing and thawing as this may denature the antibody. Should this product contain a precipitate we recommend microcentrifugation before use.
