Specificity	Rabbit anti Human CD156b antibody recognises the C-terminal region of the TNF alpha converting enzyme (TACE), designated CD156b at the 6th leukocyte typing workshop. TACE is a membrane-bound metalloprotease disintegrin belonging to the mammalian ADAM family.
