Product Form	A monovalent human recombinant Fab selected from the HuCAL® phage display library, expressed in <i>E. coli</i> . The antibody is tagged with a myc-tag (EQKLISEEDL) and a double extended Strep-tag (SAWSHPQFEKGGGSGGGGSAWSHPQFEK). This antibody is supplied lyophilised.

Specificity	HCA100 is a recombinant antibody with specificity for Green Fluorescent Protein. It has no known reactivity with mammalian proteins or other antigens. It is therefore recommended as a negative control reagent when using other HuCAL antibodies of the same format. It is recommended that this reagent is used at the same concentration as the test reagent.
Storage	Prior to reconstitution store at +4°C. After reconstitution store at -20°C. Storage in frost-free freezers is not recommended. This product should be stored undiluted. Avoid repeated freezing and thawing as this may denature the antibody. Should this product contain a precipitate we recommend microcentrifugation before use.
Shelf Life	12 months from date of reconstitution.
