Specificity	HuCAL Fab-Cys-H Negative Control, clone AbD14891 , is a recombinant antibody with specificity for Green Fluorescent Protein. It has no known reactivity with mammalian proteins or other antigens. It is therefore recommended as a negative control reagent when using other HuCAL

antibodies of the same format.

It is recommended that this reagent is used at the same concentration as the test reagent.

Storage	Store at +4°C or at -20°C if preferred. Storage in frost-free freezers is not recommended. This product should be stored undiluted. Avoid repeated freezing and thawing as this may denature the antibody.
