By immunoelectrophoresis, Purified Bovine IgG1 (**PBP003**) reacts with bovine IgG1. No reactivity was observed with antiserum specific for bovine IgG2, IgA or IgM. Purified Bovine IgG1 (**PBP003**) contains <1% IgG2, IgA and IgM as determined by ELISA.
