Specificity	Goat F(ab&prime)₂ anti Rat IgG heavy chain antibody recognizes the heavy chain of rat IgG. Goat F(ab&prime) ₂ anti Rat IgG heavy chain antibody may also react with IgG from other species. It has been cross adsorbed against rat IgM.
Storage	Store at +4°C or at -20°C if preferred.

This product should be stored undiluted.

Storage in frost free freezers is not recommended. Avoid repeated freezing and thawing as this may denature the antibody. Should this product contain a precipitate we recommend microcentrifugation before use.
